The date, information, etc. about it will be placed on Facebook, Nextdoor by Beth Wylie starting in September and throughout the two months. E. A packet will be prepared for the Party with basic information about the Association, Committee set ups, potential projects for the Association, what the people would like to see done, officer names and numbers, etc. etc. Patrick said he would take care of this. All officers should help!
- It was voted to retain a mailbox at the Hefner Station for the Association to be maintained by the Treasurer.
- There was general discussion about our mission, etc. The surveys in the packets should give us more data
 in order to conclude some ideas, etc. People also looked at the BlueStemPropertyOwners INC By-Laws
 which is the official name of the group.
